**ALL PARTICIPANTS MUST EXECUTE THE FOLLOWING WAIVER AND RELEASE OF LIABILITY**

As a condition of my being permitted to participate as a volunteer/competitor in the 2024 Clay Lodge #301 A.F. & A.M. Fishing Tournament, Lake Chatuge, Hayesville, NC (the "Event"), an opportunity available to a limited number of people, and for other goods and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and intending to be legally bound, ,

I agree to the following:

**Physical Condition**

I am physically fit to participate as a volunteer/competitor in the Event, and have not been advised otherwise by a medical practitioner.

**Equipment and Facilities Inspection**

I agree that before I participate as a volunteer/competitor in the Event, I will inspect the related facilities and equipment. I will immediately advise the supervisor of the Event of any unsafe condition that I observe. I will refuse to participate in the Event until all unsafe conditions observed by me have been remedied.

**Assumption of Risk**

I understand that I, and each participant in the Event, will be engaging in activities that involve the risk of serious personal injury, illness, permanent disability, dismemberment and death, and that also involve the risk of severe economic and property loss and damage. I understand that these risks may result from the actions, negligence, fault, omission and failure to act of myself and others (including but not limited to Clay Lodge #301 and other participants in, and the sponsors, organizers and volunteers of the Event) and from the rules of play, the challenges of the Event and the condition of any property, facilities or equipment used. I also understand, that there may be risks involved which are not known to me or to the Distributors, sponsors, organizers, Clay Lodge #301, The Grand Lodge of North Carolina, and other volunteers, and may not be foreseen or reasonably foreseeable by any of them or us at this time or at the time of the Event.
